- Scholarships and educational projects: For decades, SSVP India has been transforming lives by providing educational grants and assistance to individuals from disadvantaged backgrounds. This support targets the most underprivileged students, including those in primary, vocational, and undergraduate education. Funding is provided to students from families typically living on less than £80 a month.
- Livelihood support and income generation projects: SSVP India operates a variety of small to medium-scale projects and initiatives to help families develop new livelihoods through start-up grants or loans. In some areas, this is managed as an interest-free credit fund, creating a sustainable system that will continue to assist new beneficiaries on a rolling basis into the future.
