Flights & airport transfer

- Jeremy Perrin (CaminoWays) shared that Ryanair is currently in dispute with the Spanish government regarding taxes, and Ryanair has threatened to stop all flights to Spanish regional airports, including Santiago de Compostela (see article here).. Unfortunately, this is out of our control. If any further updates are received, all walkers will be notified.
- Airport transfers will be arranged nearer the time, once all walkers arrival times and airports are confirmed. Please be assured that airport transfer to your starting hotel is included in your trip costs and will be arranged.
- Santiago airport has announced closure from 23rd April for a month anyone who
 is staying on for longer should be aware (https://www.csj.org.uk/news/santiago-airport-closure-2026)
